- Hacking and/or coring of structural elements such as columns, beam and load bearing walls unless designed and approved by Professional Engineers
- Contract period as above and Maintenance period not exceeding 12 months
- Work with height exceeding 30 feet from ground level
- Exterior work including construction, civil engineering, piling, excavation, sub-structure works, demolition
- Work on board vessel/rig/platform
- Work at chemical/petro chemical/refinery plants/clean room/airport/wafer plants
- Work involving tandem lifting/hoisting operation
